



REGULATION

(Art. 10 L. R. Toscana 8/2006 and Art. 49 DPGR 23R / 2010)

- 1) The swimming pool is reserved to the guests of “Il Maestrale” farmhouse and it is open from 8.30 a.m. to 2.00 p.m. and from 4.30 p.m. to 8.30 p.m.
- 2) The lifeguard is not present.
- 3) The pool has n. 1 basin of 12 m x 4 m and with a depth of 140 cm.
- 4) 24 people can stay simultaneously in the pool.
- 5) Toilet, shower and changing room are in your accommodation.
- 6) The cleaning water is collected and drained away in accordance with law.
- 7) Children under 14 years old and persons with reduced mobility can access only when accompanied.
- 8) The controls of the water parameters are constantly monitored and registered in accordance with law.
- 9) It is forbidden to cross the fence. Please, keep the gate closed.
- 10) Before entering:
 - a) Wear rubber slippers or clogs.
 - b) use the appropriate machine to sanitize feet and shoes.
- 11) Before entering the water, take a shower, and wear a swimming cap
- 12) It is forbidden to dive. The depth of the basin does not allow it.
- 13) Enter gradually and allow three hours from the meal.
- 14) Do not swim in case of storms or bad weather.
- 15) In case of emergency:
 - a) use the life buoy.
 - b) Use the first aid point, in the building on the left, indicated by appropriate signal and equipped with firstaid kit.
 - c) use alarm system.
 - d) emergency telephone number: 118.
 - e) the manager of the pool: Daniela Petruzzi , mobile telephone 3314032137.
- 16) The guests who don't follow the rules (at no. 1, 4, 10, 11, 12, 14) will be sanctioned by pool manager with verbal warning or expulsion (Art. 49 n.5 DPGR n. 23/R/20109). Your precious collaboration is required to respect the regulation. Happy holidays and thanks for your cooperation.
